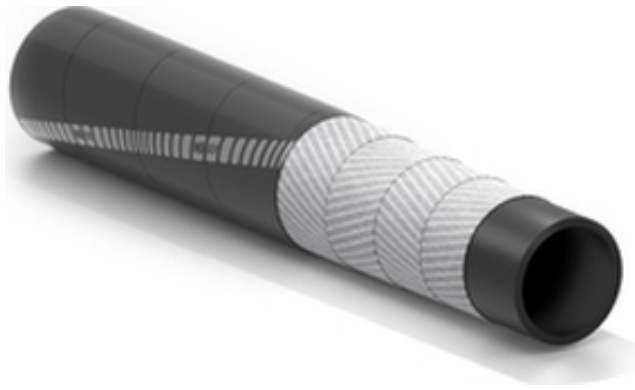


Luwas® 30
