Specifications:

Rubber cover flame retardant according to ASTM C-542. Tolerances on ID according to UNI EN ISO 1307:1997. Tolerances on wall thickness from 5,1 mm to 7 mm: +/- 0,7mm - from 7,1 mm to 10 mm: +/- 0,8 mm.

Tube:

black, smooth, insulating EPDM rubber, suitable to convey hot water, process water, corrosion inhibitors and water mixed anti-freeze agents.

Reinforcement:

high strength synthetic cord.

Cover:

black, smooth (wrapped finish), insulating CR rubber, resistant to weather, ozone, radiant heat electric arc furnaces process, self-extinguishing according to ASTM C-542.

Application:

softwall hose used as sleeves for cooling electrical cables. Elongation percentage: +-2% with hose at working pressure. - BENDING RADIUS AT THE PRESSURE OF 1 BAR -

Temperature:

from -40°C to +90°C, up to +110°C shortly.

Electrical resistance:

R>1x10¹¹ Ω /m. Breakdown voltage > 6kV/mm.
